Fixed for hearing on **19/07/2019**.

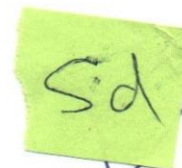
CA(IB) No. 457/KB/2019 is already disposed of.

CA(IB) No. 548/KB/2019 is filed by one another Operational Creditor to condone the delay for accepting its claim by the Resolution Professional. Resolution Professional is to file affidavit-in-reply within one week by giving copy to the applicant and the applicant is to file rejoinder, if any, within 7 days thereafter by giving copy to the Resolution Professional.

CA(IB) No. 549/KB/2019 is an application filed by the Resolution Professional for extension of the CIRP period u/s. 12(2) of the Insolvency and Bankruptcy Code, 2016. The Committee of Creditors (CoC) in meeting held on 29/03/2019 has passed a resolution by 95.2% voting share instructing the Resolution Professional to file this application for extension of CIRP period.


Heard the Ld. Counsel for the Resolution Professional. CIRP is in progress. Hence, this application is allowed. Time is extended by **90 (ninety)** days from 10/05/2019. Resolution Professional is to complete the resolution process within the extended time period.

Hence, CA(IB) No. 549/KB/2019 is disposed of.

CA(IB) No. 573/KB/2019 is filed by one of the Operational Creditors. Resolution Professional is to file affidavit-in-reply within 2 weeks by giving copy to the applicant. Applicant may file rejoinder within 1 week thereafter by giving copy to the Resolution Professional.
